BELMONT COUNTY RADIO SYSTEM UPGRADES

BearCom is actively working on the Microwave and Paging cutover. Final testing and installation is currently underway. This process will require certain "hops", or connections between towers, to be down occasionally for very short periods. The outages should not have drastic effects on paging or radio communications. We will make every attempt to notify everyone well in advance of any down time. Additionally, we may ask you to monitor your radios and Active911 as a back-up to the paging system during these times. We will be sure that these cutovers do not occur while major incidents are active.

This process will be ongoing for the next month or two. Please be patient as they work to getting the system completed and back in service.

OHIO BURNING BAN IN EFFECT FOR OCTOBER AND NOVEMBER

Just a reminder to all departments that during the months of October and November there is to be no open burning during the hours of 6:00 a.m. and 6:00 p.m.

Ohio Revised Code 1503.18 Ohio DNR Forestry prohibits outdoor open burning and prescribed fires during the restricted dates and times, which includes burning of yard waste, trash, and debris, even in a proper barrel. Even outside the time and date restrictions, any person conducting a burn must obtain landowner permission, remain with the fire while it is burning, and take all responsible precautions to prevent the fire from escaping. Ohio Administrative Code 3745.19 is enforced by the Ohio EPA. Notification is required for many types of open burns in Ohio.
