RADIO REPAIR PROCEDURES

This is a reminder to all agencies who have **county owned** mobile and portable radios. If the following is needed, for a county owned radio, it MUST go through Belmont County 9-1-1 and the work MUST be performed by Bearcom (Staley's) for it to be covered under our maintenance agreements:

- 1. Radio repair of any type
- 2. Radio removal from a vehicle
- 3. Radio install into a vehicle
- 4. Radio programming, including talkgroup or template changes

With this being said, if the radio needing repair, removal or install is NOT a county owned radio (i.e. one purchased by your department or obtained by a grant), then you are responsible for all costs associated with that radio.

Do not just call Staley's direct to arrange these procedures, for county owned radios. Call the 9-1-1 Admin Office at 740-695-9104 and we will approve the work, complete the paperwork, schedule the appointment and cover the costs.

9-1-1 RECOGNIZED BY THE STATE OF OHIO 9-1-1 OFFICES

Belmont County 9-1-1 was recently recognized by the State of Ohio 9-1-1 Program Office for having 100% compliance with new PSAP rules outlined by ORC and OAC. The new rules have been in place since May of 2016 and annual compliance checks began in May of 2018. Belmont County 9-1-1 was the first county in the State of Ohio to submit our 41-page report and we had zero deficiencies. A lot of hard work went into getting prepared for this and I want to thank our staff of Jim Delman, Tony Gregor and Alisa Scott for helping to gather and organize all of the data.

RADIO SYSTEM UPGRADE UPDATE

We are beginning to work on upgrades to the radio system, utilizing the renewed levy funds approved back in 2017. The first phase will be upgrading our existing microwave on the towers in the county. The existing microwave was first put in place in 1998. The new ethernet microwave system will increase our bandwidth over three times that of the existing technology. This will allow us to expand our existing microwave to include more efficiency, better communications, and expansion to other assets in the future.

Additionally, the voice paging system will receive an upgrade. Paging bases at all towers will be replaced, the main paging terminal will be upgraded and replaced, one additional paging base will be added to the Armstrong Mills tower and all fire department voice pagers will be replaced.

9-1-1 PHONE SYSTEM UPGRADE

We are currently working with Zuercher Technologies (owner of Emergitech, our current 9-1-1 and CAD vendor) to upgrade our current 9-1-1 software from the Emergitech IP-911 system to the Zuercher 911 system. We anticipate a cutover date of sometime in October. This new system will have enhanced capabilities for assisting 9-1-1 callers and give our dispatchers a better platform for processing 9-1-1 calls. An update to the CAD system is being eyed for early 2019. The CAD upgrade will give each department a better system for reporting and call processing. Stay tuned!
